### **II FINANCE UPDATE**

\$2.5M in ACF, \$132K in two bank accounts; Membership fees are increasing in July 2021.

*There has been a real need in the community; it would be a good, continued use of funds to stock the pantry until kids are able to receive regular meals at school.*

### **III LIBRARY UPDATE**

Reopening will begin July 1, 2021 with Central, Aurora Hills, and Columbia Pike. Glencarlyn and Cherrydale will reopen in September 2021. The Maker Space is re-opening in Phase 2, since the priority is the collection and the computers. Summer Reading will begin June 1 and use a new tracking ability right in the Library's app.

LIBRARY BUDGET REQUEST: \$357K, which includes \$293K plus a special gift of \$64K in collection support to update/replace the world language materials, many of which were damaged in a recent pipe leak/resulting flood. Additionally, the Library is requesting a one-time gift of \$24K to modernize the playaway collection.
